Both the Buyer and One World Flowers, Inc. have the right to terminate the agreement at any time by giving written notice to the other party 30 days before the desired termination date.

Buyer agrees to comply with all TransFair USA product pricing, merchandising, advertising, and promotional guidelines. These guidelines can be provided by One World Flowers, Inc. or found online at [www.OneWorldFlowers.org/wholesale](http://www.OneWorldFlowers.org/wholesale). One World Flowers agrees to supply Buyer with approved marketing and point-of-purchase material to aid in product sales as the material becomes available.

An invoice will be mailed separately for each delivery. Buyer agrees to pay each invoice in full within 15 days of receipt. **If Buyer is not satisfied with the product for a reasonable cause after the delivery, send a digital photo and written request for a credit to [service@OneWorldFlowers.org](mailto:service@OneWorldFlowers.org).** All requests will be responded to promptly and credits will be applied for reasonable claims of damaged product or poor quality.
